Subject:	Content of the Official Journal series

After consulting an interinstitutional working group¹, the Management Committee of the Office for Official Publications of the European Communities has suggested a number of changes to the structure of the Official Journal (OJ) to overcome certain problems with the current classification of documents published in it.

The changes involved are minor ones. They respect the OJ's existing structure and their only purpose is to make the OJ easier to read.

The most important changes are the following:

L series:

 The French title of headings L I and L II is slightly changed to align it with the Treaties and the titles in the other languages ("Acts adopted under the EC Treaty/Euratom Treaty whose publication is obligatory/not obligatory").

Representatives of the institutions' legal services took part in this working group.

- Acts adopted on the basis of the EU Treaty will be published under a separate new heading
 (L III: Acts adopted under the EU Treaty).
- Acts adopted by bodies created by international agreements will be published under the same heading as international agreements (L II: Acts adopted under the EC Treaty/Euratom Treaty whose publication is not obligatory).
- A new heading L IV (Other acts) would contain EEA acts and rules of procedure.

C series:

- C-series acts will be divided into five new categories.
- Recommendations that are not binding acts will be published under heading C I instead of
 L II as at present. Interinstitutional agreements and joint declarations will be published under
 C II unless the institutions concerned decide otherwise.
- The "Announcements" under C V relate to procedures where publication of the announcement starts a time period running.

Following examination of this matter by the Working Party on Information on 9 November 2006, Coreper is invited to suggest to the Council that it authorise its representative on the Publications Office's Management Committee to agree to the suggested new structure in the Annex, so that the necessary steps can be taken to implement it as from 1 January 2007.
